

**Police Pension Scheme 2006 (PPS 2006) /
Police Pension Scheme 2015 (PPS 2015)
Nomination or revocation of lump sum
death grant form**



IMPORTANT: Read these notes before you complete this form

1. This form allows you to nominate a person to receive a lump sum death grant if you die in service. The amount of the grant is normally 3 times your annual pensionable pay at the time of death (or immediately before any period of absence without pay).
2. This form applies only to members of the Police Pension Scheme 2006 (PPS 2006) and Police Pension Scheme 2015 (PPS 2015). If you are a member of the Police Pension Scheme 1987 (PPS 1987), and you die in service, the grant will be paid to your surviving spouse or civil partner (if you have one) or otherwise to your personal representative (normally your estate). Contact Kent County Council Pension Section if you are not sure which Scheme you are in.
3. You may nominate anyone you like. You may also nominate as many people as you like. If you nominate more than one person, say what proportion of the grant (either a percentage or a fraction) you would like each to receive. If you do not give a proportion, we will divide the grant equally between the people you have named.
4. The form asks you to state any nominated person's relationship to you. You do not have to give this if you do not wish to, but it will help us deal sensitively with matters if you die.
5. A nomination will not be effective if at the time of your death you leave a surviving spouse, civil partner or unmarried partner who is entitled to benefits under PPS 2006 and PPS 2015. In these circumstances, the grant will be paid to that person (refer to the PPS 2006/PPS 2015 Members' guide for more information about the lump sum death grant and about survivor benefits in general).
6. You may wish to consider changing your nomination if your personal circumstances change. It is your responsibility to keep it up to date, including the address of anyone you have nominated.
7. Kent County Council Pension Section will acknowledge the nomination by letter. If you wish to revoke your nomination you must do so in writing.
8. Kent Police Authority have complete discretion over who receives any lump sum death grant, but it is helpful to know your wishes by completing this form.
